Message from the Chief Executive

It has been a month dominated by the elections and to a lesser extent the 2023 Rugby World Cup. I won't be commenting on the latter....

As reported in the previous edition of our newsletter, the run up to the elections was a busy period for lobbying and advocacy activity.

GenPro was highly active in the media, often in contact with politicians from

across the parties and we also released our Manifesto. We are now finalising the GenPro Briefing for the incoming Minister (BIM). The BIM will reaffirm our Manifesto and our commitment and desire to work with the Minister.

Now that the election process is (almost) complete, the post-election period is likely to be one of low engagement from the centre as the impact of the election, process of forming government and the resultant changes become clearer.

There was another election too - the GenPro Board election ahead of our AGM ([you can read about it here](#)).

I am hopeful that both elections will bring about the opportunity for GenPro to have increasing impact in the coming year.

We have also been working with the GPLF (General Practice Leaders Forum) and Te Whatu Ora to get PSAAP activated again. With PSAAP currently inactive, there is no forum for negotiation of contract variations, which is simply unacceptable. GenPro continues to promote the right for all Contracted Providers (entities holding a back-to-back agreement for first level services with a PHO) to be able to appoint their own agents to represent them.

We are making headway and will provides updates as this progresses.

I would like to end by welcoming our new members and thanking our current members for their support and engagement. Your feedback is always welcome and valued.

A strong message was the intent of Te Whatu Ora to engage with primary care and GenPro as the health reforms move from establishment of Te Whatu Ora to change and design for the future.

While we have heard this before, Dr Poutasi assured us that, while the conversation is yet to happen, it will. GenPro is looking forward to working closely with Te Whatu Ora in supporting change to meet the needs of general practice and their communities and providing a General Practice voice in the discussions.
