epidemiology. Prior to becoming an MP and the Associate Minister of Health, Dr Verrall worked for Capital and Coast DHB and was later elected to the DHB board.

GenPro is excited at the prospect of working with a new Minister who has a good understanding of the health system as well as an understanding of the vital role of general practice and primary care.

Engagement with the new Minister

GenPro is pleased to advise members that the Minister personally contacted GenPro Chair, Dr Tim Malloy, on her first day in the post. During a personable and positive conversation, the Minister acknowledged the vital role played by primary care and general practice and emphasised her desire for a collaborative and close on-going relationship with GenPro.

In line with the usual process for new Ministerial appointments, GenPro has provided a Briefing for the Incoming Minister (BIM) and is looking forward to an early meeting to build upon the Minister's existing relationship with Dr Malloy and to outline GenPro's vision for sustainable family doctor services as set out in [On The Brink](#).

Follow-up to ACC Urgent Care webinars

Webinars on 'Understanding Changes to the Urgent Care Contract' were run by ACC on 8 February 2023. ACC will have the webinar available on their website shortly for viewing [\[here\]](#).

The key points discussed were:

1. ACC acknowledge that Urgent Care Clinics and the wider primary care system are facing significant challenges on multiple fronts
2. ACC plan to introduce some interim changes to the Urgent Care contract from 1 July 2023, while they work on a wider service redesign in partnership with the sector
3. An invitation for expressions of interest to be part of the expert reference group working on the redesign will be sent out in the near future
