Kia ora tatou,

There has been a lot happening recently on the political front in terms of health, and; rural health in particular. There is certainly no shortage of attention to the current workforce crisis in the media and all of us know that the GP workforce, across the whole general practice team, is foremost in the shortage.



We note the much-awaited release of the Interim Health Plan, Te Pae Tata, and the references to rural health that appear in the plan. We were also invited to be part of

the Workforce Dialogue with the Minister of Health; a full-day meeting with over 300 health leaders in Parliament. These plans and meetings are all very well, but we can only judge outcomes on the tangible actions that follow. Both initiatives are currently short of follow-up actions, with associated measurable targets, that can be used to hold agencies and Government to account.

We do note that Te Whatu Ora is currently advertising and filling positions for a rural team and positions in the Primary Community and Rural Care directorate. This is something we have campaigned for and will enable us to have dedicated people within Te Whatu Ora to engage with and to help drive initiatives that will work for rural health.

Of course, there is no let-off in pressure for all of you at the coalface of rural health delivery as we enter the Christmas holiday season. We are also hearing from our Rural Communities Chapter that many rural people are feeling increasing pressure with Government legislation, pending legislation, and late grass growth, among other things, leading to stress and disillusionment for many. We need to support each other during this time, and I know the intent and passion are there from all of us to help where we can.

A number of us will attend Fieldays at Mystery Creek, Hamilton, next week in the rural health hub. Our team from Hauora Taiwhenua, with assistance from volunteer students, doctors, and nurses will be promoting the message of being aware of and looking after your health. I hope to catch up with many of you there over those days. Please drop in and see us.

With the help of Mobile Health and the combined efforts of our Rural Communities and Rural Research and Education Chapters, we have put together a short survey to get perceptions of the state of rural health. <u>Please complete the survey</u> and distribute it widely. We hope to get some baseline data and annually update this information.



The Christchurch Consensus

The release of the Christchurch Consensus has been a landmark work for us. Not only is it the culmination of a lot of discussion and collaboration with rural health professionals all over Aotearoa New Zealand, but lays out key areas of interest for Hauora Taiwhenua moving forward.



The Christchurch Consensus details priorities and calls to action that target the rural workforce crisis, unacceptably poor health outcomes for rural Māori, rurally focussed locality planning, and access to and funding of services that are set up specifically for rural areas.

With the release of Te Pae Tata/Interim Health Plan, some of the features of the Christchuch Consensus, such as the Rural Classification for Health and the inclusion of rurality data in health statistics, have been established as areas of interest by Te Whatu Ora an Te Aka Whai Ora.

The alignment of Te Pae Tata and the Christchurch Consensus is encouraging, and goes a long way to show that rural communities and health professionals are well aware of the challenges they face and solutions to overcome them. Moving forward, Hauora Taiwhenua will be instrumental in holding Te Whatu Ora to account for delivering on these key targets effectively and on time.

However, there is still plenty of advocacy work required to meet the needs of rural communities and the Christchurch Consensus is currently the framework for this advocacy.

Advocacy

Te Pae Tata/Interim Health Plan Webinar

Shortly after the release of Te Pae Tata/Interim Health Plan, we organised and hosted a webinar with Rachel Haggerty of Te Whatu Ora.

Although much of the detail of Te Pae Tata is still in development, there are some key features of the Act that are of particular interest to rural communities, including:

- A Rural Health Strategy being led by Manatū Hauora
- Initiatives that aim to address workforce shortages
- Primary Community and Rural Early Actions programme.

Changes expected to be implemented by Christmas include the Afterhours Telehealth service and the timelines and pathways for the review of rural afterhours and PRIME.



Advocacy

Health and Wellbeing Hub at the Fieldays

The Hauora Taiwhenua Health and Wellbeing Hub will be operating again at the Fieldays at Mystery Creek Event Centre in Hamilton.

In collaboration with 47 other health and wellbeing organisations, the Health and Wellbeing Hub will engage rural New Zealanders in meaningful conversations about their health with a view to reaching out to rural people visiting the Southern Hemisphere's largest agricultural event.

The Health and Wellbeing Hub's last Fieldays presence saw 40,000 people engage with health conversations, and with a team of 40 volunteers including GPs, nurses, students of rural health, and many more, we are expecting another successful visit.

Dr Jeremy Webber's Clinical Director Report

This week I've had another lesson in equity as I have joined the community for jury duty. It has reinforced the strength of a locality approach to health which addresses those socioeconomic determinants which too often dictate the health of our rural populations.

Again it has been a busy month in the health sector. I was proud to in part host the launch of Te Pai Tata the Interim Health Plan with our Tūwharetoa partners at Taupō Hospital. Despite the cameras and positivity I was able to reinforce our sector's need through the appropriate lens of post night shift. Expectantly vague on details for rural it does give us some guidance now on the next two years of delivery on health reform. The challenge obviously is how we continue to imprint rural on subsequent delivery.

I continue to contribute to Te Whatu Ora as part of my secondment into the extended community care stream and more recently input into the Hospital and Specialist Services. Increasingly Hauora Taiwhenua is being referenced as a key stakeholder and so it is essential that we meet this expectation for our rural communities. As always I welcome your comment and questions, with a particularly focus on rural diagnostics and pathways of care.

Last month I joined colleagues (pictured) at the Rural Medicine Australia conference in Canberra and also combined some teaching, division representation and my own CPD learning. The discussions in the coffee line, and more widely reflected in the plenary sessions, frequently mirrored our own challenges in New Zealand. Workforce

and the lack of clinical exposure to rural in those early post graduate years, the struggle for wider health workforce, and the day-to-day access to higher level care in a timely and clinically appropriate way, are all significant challenges.

As our rural areas prepare for the holiday onslaught there are some key actions before the year end for Te Whatu Ora and Te Aka Whai Ora and we will continue to ensure rural has prominence in that mahi.

This recent study focuses on travel required for patients to access surgery for liver or stomach cancer in New Zealand, particularly for Māori. Gurney et al. find that that Māori on average travel twice as far for cancer surgery compared to Europeans.

In this paper, 10% of acute hospital admissions, transfers and arranged admissions for Māori are to hospitals outside of their home domicile which increases with higher levels of deprivation. With around 25% of Māori living rurally the burden of travel is even greater. Let's hope Te Whatu Ora & Te Aka Whai Ora make this a priority in addressing health disparities.
